

## **INTERPLAY SCHOOL REGULATIONS**

### **2010-2011 SEASON**

#### **Early Registration**

- Early Registration Discount applies during the specified dates each spring for current students only. After this date, regular fees will apply. Discounts apply so that we can solidify classes, staff and guarantee student placement.
- 10% full year payment discount applies on or before June 9, 2010 for current students only. Please note: If student withdraws from the program, the year fees will be non-refundable.
- 5% post-dated year payment discount applies on or before June 9, 2010 for current students only. If student withdraws from program prior to commencement date, the 1<sup>st</sup> term will be forfeited. All remaining post-dated payments will be returned.
- Charge card Term & Monthly withdrawals are available.
- Interact payments may be taken for the 1<sup>st</sup> term payments or Store payments.

#### **Yearend Performance Costumes**

- Costume Deposits and Performance Fees will be paid on September 1<sup>st</sup>, 2010 and are non-refundable.
- Costumes are bought for all dance forms except for the Intensive Ballet Division. These costumes are quite expensive and will be rented from our studio only. Musical Theatre and Modern dance forms will also pay a rental fee only.
- Costume rentals and deposits are non-refundable as our costumes are bought from the U.S. and must be ordered by the beginning of the year.
- Costumes will be no more than \$135.00 and are kept by our students after the yearend performance. Rental costumes are the property of Interplay and must be returned at the final performance to our costume wardrobe staff.

#### **Sibling Discounts**

- The first student will submit a regular fee payment, then a 5% discount will apply for the next year to all siblings who are minors within the same immediate family.
- If one student from the same family withdraws from a class or the school, the remainder of that student's term fee is not transferable to the other sibling. The remainder payments will be returned.
- This discount will not apply to early registration students.

#### **Withdrawal**

- A written withdrawal must be received in our office 5 business days prior to the payment date for following term. Once payment has been made for next term that term will be forfeited. The remaining payments will be returned.
- In the case of withdrawal mid-term, no refund will be returned for the remainder of that term.
- If a student enrolls in multiple classes and drops one/more classes, the remainder of the term is not transferable to remaining terms. The remaining payments will be altered to new fees.
- Registration fees are non-refundable.

#### **Classes**

- Classes run from September to June
- Students who are not on the teacher's class list will not be able to participate without a trial class slip. (see our office for trial class slips)
- Class size is limited. Ask our office for class size limits.
- There will be no make-up classes. An exception will be made if it is due to cancellation by Interplay.

#### **Trial Classes**

- New students may observe a class but may not participate unless the registration and waiver form have been completed
- All students wishing to participate in a class must have a trial class slip from the Interplay office or they will not be permitted to dance.
- Concluding the trial class, the student must then be registered and on the teacher's class list before they are able to continue in that particular class.
